2026 HFFCF TWILIGHT PARADE **GENERAL RULES**

1. **No Alcoholic beverages, vape pens containing recreational drugs or recreational drugs are allowed on floats, any entry, and in staging area.**
2. **MOUNTED GROUP:** All mounted groups must have a ground point person to keep the group together (review #4), minimize gaps and spectator interference and must have someone following to pick up after your animals. **Insurance certificate required, naming HFFCF additional insured and a list with the names of all riders.**
3. No ties will be allowed in judging. Trophies will only be awarded in classes where competition is present. (i.e., more than one entry in class)
4. All single entries are limited to **65 feet in length, 12 feet in height from the ground.** This includes Mounted Groups, Marching Bands and Organized Groups.
5. Hot Rod entries are allowed but only as a single entry (1 car per entry).
6. All units must always be in forward progress. Deduction of points and possible disqualification could result from any delay or stoppage of the parade. **KEEP MOVING AND NO GAP OF MORE THAN 50 FT.**
7. Entries must be representative of what is indicated on the entry form, i.e., the marching unit must remain in marching formation.
8. Tossing or throwing candy, toys, water balloons, or any other item will be grounds for immediate disqualification and removal from the parade. People walking along the entry may hand out items. **SPECTATORS MUST NOT BE ENTICED INTO THE ROADWAY.**
9. **No street vendors** will be allowed at any time during the parade and **NO selling of any items/tickets from parade** entry participants allowed throughout parade route.
10. All entries must adhere to parade rules along with city, state and federal rules and regulations. All entries need to put SAFETY FIRST! i.e., helmets are required if riding bicycles, skateboards etc.
11. The Future Farmers Fair Parade Committee reserves the right to reject or disqualify any entry.
12. **HAVE FUN!!**

*Not adhering to these rules will result in immediate removal from the Parade and possible future consequences.
